## Treasurer's Report: Jack Mason

Jeanine received extraordinary compliments from Bare Boat Charters for her management of the Labor Day Sail. She came within \$125 of the \$25,000 trip.

Jack announced this will be his last year as Treasurer. He has been Treasurer for 5 years.

- b. Stratton, Vermont Jan 14 17, 2020: Eight rooms have been reserved. Trip advertised.

- c. Ischl, Austria January 24 February 1, 2020: Thirty-one have signed up.
- d. Steamboat Springs, Colorado February 22 29, 2020: Thirty-two have signed up, 6 are on wait list. Chester will look into having the Apres-Ski parties in the hotel which would better accommodate a larger number of people, as opposed to gathering in a hotel room.
- e. Killington, Vermont March 15 18: Chester will ask the Lodge to reserve ten left tickets. There will be no financial impact, as they may be cancelled up to a couple of days before the trip.
